

## City of Lake Stevens Halloween Coloring Contest 2021 – Official Contest Rules

1. This is a skill-based contest and chance plays no part in the determination of winning. All entries must be original and entirely created by the entrant.
2. Contest begins October 11, 2021 and ends October 29, 2021 at 4:00 pm PT.
3. To enter, print out the coloring page based on the entrant's age and color using crayons, markers, or colored pencils, only. Drop off or mail your completed coloring sheet to City of Lake Stevens City Hall, PO Box 257 1812 Main Street, Lake Stevens, WA 98258.
4. Entries must be received by Friday, October 29, 2021, 4:00 pm, when City Hall closes for the day. Mailed entries must be postmarked by October 29, 2021. Alternately, email completed entries to [marketing@lakestevenswa.gov](mailto:marketing@lakestevenswa.gov) with subject line "Halloween Coloring Contest 2021". The City is not responsible for lost, late, or misdirected entries, or incomplete/incorrect entries.
5. Entry must include entrant's first name, age (at time of entry), a parent or legal guardian's full name, telephone number and/or email address. Any entries missing the above requirements will be immediately disqualified.
6. Winners will be chosen and announced by November 5, 2021 on the City's Harvest Fest website post and social media. Potential winners will have five (5) business days to respond, or he/she will forfeit the prize and an alternate winner will be selected.
7. Entries will be judged by City of Lake Stevens staff based on creativity, coloring skill and overall artistic ability according to that age category. One winner from each age group (0 - 5, 6 - 9, 10 - 17) will be determined by the judges in their sole discretion. The decisions of the judges will be final and binding in all respects.
8. Prizes: Prizes are sponsored by Gold Creek Community Church; one (1) prize, in the form of one (1) \$25 gift card will be awarded to each age group. The 0 – 5 category prize is one (1) \$25 gift card to Kaliki's Hawaiian Shave Ice, the 6 – 9 category prize is one (1) \$25 gift card to Blue's Frozen Yogurt, and the 10 – 17 category prize is one (1) \$25 gift card to Lake Stevens Donuts. Gift card prizes are not endorsed, sponsored, or administered by Lake Stevens Donuts, Kaliki's Hawaiian Shave Ice or Blue's Frozen Yogurt.
9. Limit one (1) entry per child. Winners will be notified by email and/or telephone number provided. Contact information collected will be used for the purposes of this contest only and will not be used for marketing or other purposes.
10. Once verified by the City representative, the winning entrants will be contacted by a Gold Creek Community Church representative for prize fulfillment.
11. Children of City of Lake Stevens employees are not eligible to enter.
12. All winning entries will be posted on the City's webpage and social media outlets.
13. Entries will not be returned once submitted.
14. The City of Lake Stevens reserves the right to disqualify anyone who attempts to tamper or otherwise interfere with the proper functioning of the promotion.
15. By participating, Contest entrants: (1) represent that they have complied with these Official Contest Rules; (2) have received parental consent and grant the City of Lake Stevens the public sharing of the contest submission on the City's website and social media outlets and (3) release the City of Lake Stevens from all liability in connection with this Contest.
