**LICENSE TAG MUST BE AFFIXED TO PET**

All dogs and cats shall be licensed within sixty days of City residency, including dogs and cats in newly annexed areas. (Ordinance No. 820, 5.12.030.F.) Lifetime pet licenses will be free if application is submitted within sixty day period; otherwise pet license will cost \$20 per pet. The City of Lake Stevens requires licensing of cats and dogs. Upon receipt of a completed application form and fees, if applicable, the City shall issue the appropriate license tag to the applicant. If a license tag is lost or unreadable the owners shall obtain a new tag from the City of Lake Stevens by written reapplication and payment of the applicable fee.

Kennel/Commercial Animal Rearing (Not allowed in residential zones)
